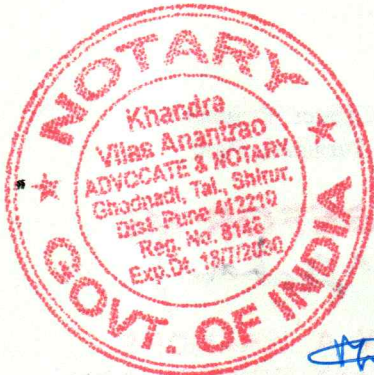

I the education officer (Primary), Pune Zilla Parishad Pune award the temporary sanction and recognition to St. Joseph Eng Med School, Shirur run by St. Joseph Educational Trust, Shirur, St Pune. The Period of 1 April 2019 up to 31 March 2022.

The Above recognition is given subject to the fulfilling the following conditions

1. The Period of Recognition will not be extended and there will be no restriction and objection in giving recognition or affiliation after Std 8.
2. The school will follow the Right to Free and Compulsory Education for children Act 2009 (Annexure 1) and Maharashtra Right to Free and Compulsory education Rule 2011 (Annexure 2)
3. The School will give minimum up to 25% of total students in that admission in std 1" to the weaker section and deprived section children from the nearby area will continue till completion of the primary education also in addition the same followed in the pre- primary education also.
4. For the children mentioned in point 3 the school will be given reimbursement the school will be given a separate Bank account.
5. Society/ School will not collect any capitation fees complete to undergo any process of scrutiny of child or the parent of the child or the guardian.
6. The school will not reject admission of the child on the basis of proof of age, Religion, Caste, or Creed, birthplace or any one of this.
7. (i) The admitted student will not be retained in same class studying or will not be removed from the school till he/she completes the primary education.
(ii) Will not harass the child physically or mentally.
(iii) It is not necessary to pass any board examination to any child till completion of the primary education.
(iv) The student will be awarded prescribed certificate as per rule 23 after completion of Primary education.

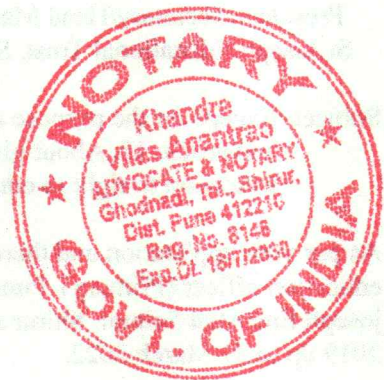


- (v) Children with special need included as per statutory provision.
